**HOURS OF OPERATION:** Tuesday, Thursday, and Saturday 8 AM – 3:45 PM

**STICKERS:** A valid sticker is required for entry to the Transfer Station. The sticker must be affixed on the inside lower driver's side corner of the windshield. Stickers are available from the Town Clerk, 25 High Road, Newbury during normal business hours at Town Hall and are valid for the calendar year specified.

### Effective for 2012 calendar year

#### Sticker fees:

Residents	\$175
Seniors (65 & older)	\$85
100% Disabled Veterans	1 sticker only at no cost
Additional Sticker	\$50
Replacement Sticker	\$10

One (1) additional Sticker per residential address may be purchased at a cost of \$50. Applicants must be legal town residents or residential property owners. A valid driver's license, Town assessor records, or a copy of a tax bill for a residential property shall be provided as proof of residence. Vehicle registration must be presented for each sticker purchase and the vehicle owner must be an eligible applicant. Each sticker is associated with the vehicle specified and is not transferable.

If a vehicle is sold, transferred, or the windshield replaced, the sticker must be removed from the vehicle and returned to the Town Clerk. A replacement sticker will be issued for \$10. Otherwise, a new sticker must be purchased.

The Town Clerk may issue short term Transfer Station permits to valid sticker owners in the following circumstances: 1) primary vehicle under repair, 2) larger vehicle needed, 3) illness of primary sticker owner. Without exception, these temporary permits are subject to all Transfer Station regulations and fees.

**GENERAL DISPOSAL RULES:** All users of the facility must follow the instructions of Transfer Station attendants or other personnel authorized by the Newbury Board of Health. Identification must be shown upon request.

All signage directing the placement of waste and recyclables must be observed. Use of the facility is limited to the disposal of **residential** waste and recyclables generated in the Town of Newbury. Material transported to the site is subject to inspection. **No commercial or out-of-town disposal allowed.**

Any violation of the above rules is subject to revocation of sticker and denial of access to the transfer station, at the sole discretion of the Newbury Board of Health. Persons on the site who fail to display a proper sticker or to follow the above rules may also be cited by the Newbury Police for trespassing or other violations of local or state code.

**ADDITIONAL GUIDELINES:** For safety's sake, small children must stay in the vehicle. Please help prevent windblown litter by using bags or containers as needed for loose paper, plastic packaging, etc. When using the waste oil dump use care to avoid spillage. Use caution and common sense in parking, for the safety and convenience of other patrons.

Landlords are responsible for trash disposal of tenants of seasonal rental properties for less than two (2) weeks duration.

**DUAL STREAM RECYCLING: One compactor for paper, the other for containers.  
PLEASE DO NOT DEPOSIT PLASTIC BAGS**

**Paper and Cardboard:** All paper and cardboard including newspaper, junk mail, magazines, catalogs, spiral notebooks, clean pizza boxes and all books.

**Co-mingled Containers:** All glass bottles, tin and aluminum cans, juice cartons, aluminum foil, yogurt cups, empty aerosol cans, zip lock bags and plastic containers marked #1 - #7. No Styrofoam (even with numbers 1-7), window glass, light bulbs, or fluorescents.

**Fee Items:** Handling of other recyclable items requires a fee to help defray disposal cost. Coupons may be purchased at the Police Station. Please hand your coupon to an attendant who will direct you to the proper location to drop off any of the following:

Small metals	Toaster, iron, metal window, etc (each 5 items) 5
Propane tanks	<b>Please do not put propane or gas tanks in with other metals</b> 5

Electronics	Computer, stereo, VCR, printer 15
Batteries	Automotive 2
	Small dry-cell or rechargeable (see attendant) 0
Waste oil	Per quart .10
Tires	Auto/light truck (no rim) 3
	Truck/Tractor (no rim) 18" and up 15
Paint**	Oil accepted. \$2/gal.\$1/qt.
Wood/Wallboard	Trunk Load \$25. Level P/U \$75. Heaping P/U \$100.
Fluorescent Bulbs	Small light bulb \$.20 ea. Large tube bulb \$.20 per foot

**\*\*Latex paint and empty paint cans:** Allow paint to harden in the can or spread on cardboard to dry then place in regular household trash.

**YARD WASTE AND BRUSH:**

The Newbury Transfer Station does not currently handle yard waste or brush. Disposal of these items in the solid waste container is prohibited.
