GREETINGS:

IN THE NAME OF THE COMMONWEALTH OF MASSACHUSETTS, YOU ARE HEREBY DIRECTED TO NOTIFY AND WARN THE INHABITANTS OF THE TOWN OF NEWBURY, QUALIFIED TO VOTE IN TOWN AFFAIRS, TO MEET AT THE NEWBURY ELEMENTARY SCHOOL ON HANOVER STREET IN SAID TOWN OF NEWBURY ON TUESDAY, THE 24<sup>th</sup> DAY OF MAY 2011 AT 7:00 P.M. TO ACT ON THE FOLLOWING ARTICLES, VIZ:

**ARTICLE 1.** To see if the Town will vote to transfer from Town Administrator Salary line-item in the Fiscal Year 2011 budget the sum of \$6,000.00 and from Town Accountant Expense line-item in the Fiscal Year 2011 budget the sum of \$2,500.00 to Street Lighting; or act in relation thereto.

**ARTICLE 2.** To see if the Town will vote to transfer from Highway Labor Wages line-item in the Fiscal Year 2011 budget the sum of \$35,000.00 to Health Insurance; or act in relation thereto.

**ARTICLE 3.** To see if the Town will vote to transfer from the Stabilization Fund the sum of \$191,777.77 to cover the Snow & Ice deficit; or act in relation thereto.

**ARTICLE 4.** To see if the Town will vote to transfer from the Stabilization Fund the sum of \$5,000.00 to the Plum Island Beach Management line-item; or act in relation thereto.

**ARTICLE 5.** To see if the Town will vote to authorize the payment of a fiscal year 2010 bill from Newbury Animal Hospital in the amount of \$256.95, said sum to be taken from the Animal Control Expense Account Number 100-202-5380-000; or act in relation thereto.

**ARTICLE 6.** To see if the Town will vote to authorize the payment of certain fiscal year 2010 police department medical bills totaling \$4,142.36 relating to an on the job injury, said sum to be taken from the Stabilization Fund; or act in relation thereto.

AND YOU ARE HEREBY DIRECTED TO SERVE THIS WARRANT BY POSTING AN ATTESTED COPY THEREOF IN EACH VOTING DISTRICT, FOURTEEN DAYS AT LEAST BEFORE THE TIME OF HOLDING SAID MEETING.

HEREOF, FAIL NOT, AND MAKE DUE RETURN OF THE WARRANT WITH YOUR DOINGS THEREON TO THE TOWN CLERK AT THE TIME AND PLACE AFORESAID.
