#### Call to Order:

At 7:00 p.m. Chair Alicia Greco called the meeting to order with a salute to the flag

Motion: JR Colby moved to open the meeting seconded G. Walker, and voted unanimously

Discussion: None

#### **New Business:**

Eagle Scout Project presentation – Patrick Sasso

Patrick Sasso, Troop 44, presented his flag pole project at Central Street field to the Board. Described as a 25' aluminum flag pole. Stated the DPW and Recreation Committee approved and work would begin June 11<sup>th</sup> and finish June 12th

Motion: JR Colby moved to approve eagle scout project seconded G. Walker, and voted unanimously

Discussion: Discussion ensued

#### **Public Comment:**

Leslie Matthews, 111 Main Street, discussed the tragic accident at Byfield Greenhouse. Ask to add something into Newbury Town Day to honor the family, informed the Board they will reopen this Saturday at 10:00 a.m. and encourage people to stop by and support the family

Justin Londergan, 38 Larkin Road, read part of a letter that he stated 50 citizens in Newbury and Georgetown sent to the Newburyport News. Also, acknowledged a letter he received from the Town Administrator. Read excerpt from Mass Law Part I, Title 14, Chapter 82. A. Greco provided some information on the topic

G. Heavey asked to place Larkin Road on the next Select Board Agenda

A.Greco replied it would be considered

A.Greco asked if any more Citizens concerns and stated only two minutes left

Bob Ross, 48 Larkin Road, mentioned the Will of the People and asked why the Town is not supporting

JR spoke regarding the path laid out by Town Counsel

Public Hearings: 7:15 p.m.

National Grid and Verizon Pole Petition – JO pole 24-1, 26th Street

Motion: JR Colby moved to open the public hearing seconded G. Walker, and voted unanimously

G. Walker read the Public Notice

**Motion:** JR Colby moved to approve the Petition of National Grid, Plan #0527113, 26<sup>th</sup> Street, Newbury seconded G. Walker, and voted unanimously

Discussion: National Grid representative, John Butler spoke to the petition request and answered the Boards questions

National Grid and Verizon Pole Petition - JO poles 142, 141, 140, and 139, Middle Street

G. Walker read the Public Notice

Motion: JR Colby moved to open second public hearing seconded G. Walker and voted unanimously

Motion: JR Colby moved to approve the Petition of National Grid, Plan #28767660, Middle Road, Newbury, seconded, G. Walker, four notes in favor, D. Packer recused

Discussion: National Grid representative, John Butler spoke to the petition request and answered the Boards questions

Motion: JR Colby moved to close the pole petition public hearing seconded G. Walker and voted unanimously

Dog Nuisance/Dangerous Hearing – Owner: James Pearson, dog Epic

**Motion:** G. Walker moved to open the Dog Nuisance/Dangerous Hearing seconded, JR Colby and voted unanimously

Discussion: A.Greco read the Public Notice delivered to Mr. Pearson. And read the list of documents received into record

ACO, Carol Laroque spoke to the Board. Stated she has no jurisdiction to what happens in a person's home. Mentioned the Order of Restraint she issued requiring a leash and muzzle while outside. Ms. Laroque stated she

has observed Mr. Pearson walking the dog with muzzle. Stated she herself has not witnessed the dog being walked without muzzle

Ms. Benoit spoke to the Board. Explained the bite event in her words. Explained she was watching tv on couch in a reclined position. Dog was out of his pen. Dog charged her, she put her leg up and then the dog was on couch, dog got a hold of her. Jim screamed at her to get into the bathroom. Was wearing turtleneck and heavy sweat shirt feels would have ripped her arm off if she had not. She has to go into the bathroom when Mr. Pearson takes the dog out

Ms. Benoit mentioned she has letter from another trainer indicating dog is dangerous. Currently using their rental property for the dog. Stated she has more surgery ahead as the dog went down to the bone. She fears the dog will do it to someone else. Stated Jim said the dog was playing. She feels differently. She would like the dog to be re homed, so she does not have to worry. Does not want to be in her own yard when the dog is out there. Commented others can verify the dog does not like her.

Attorney Jeremy Cohen with Boston Dog Lawyers asked questions of the ACO, Carol. Stated there was a perception there was a violation of an order as Mr. Pearson was ordered to have dog muzzled. Explained the problem is canine restraint was issued. Mr. Cohen asked who authorized ACO to issue the restraint. ACO stated was her responsibility to keep public safe. Mr. Cohen stated she does not have authority to issue muzzle order. Only after hearing can a muzzle restraint be put in. Chief Lucey spoke and explained he ordered ACO, Carol to order restraint. Mr. Cohen stated Mr. Pearson was not in violation of an order. Mr. Cohen also asked ACO, Carol about the notification from the hospital. ACO replied the report went to the police then to the ACO. Carol did call the hospital to find out the extent of the wound. Bite report indicated bite. Nurse reported was a vicious bite. Mr. Cohen asked as animal inspector, was the nurse authorized to provide that information. ACO replied she did not know.

Attorney Cohen, gave a statement regarding his time spent with Mr. Pearson. Provided a back ground regarding the dog, previous owners, and how Mr. Pearson adopted the dog. Stated Mr. Pearson wants more time to work with the dog.

Stated Pearson moved dog to the other house. Talked about K9 Edge training and the progression the training has provided. Mentioned Akc cgc, certificate which entails a 10-part test. Training conducted by Specialized trainers. Owner and dog must go to training. Stated Mr. Pearson has made commitment to his dog.

Attorney Cohen called witness, Cathy Copeland, K9 Edge, 20 years of dog training. Specializes in power breeds. Attorney Cohen asked Cathy to share her information how she met Mr. Pearson. Stated she was asked to evaluate Epic. She Observed them on leash then when taken off lease Epic did not show aggression towards her. Have had 8 sessions to date. Obedience, recall. Epic now does several commands. Mr. Pearson doing all the homework training she has asked him to do and above and beyond. Attorney Cohen asked her to talk about the akc cgc. She believes Epic will be able to attain that status. In her opinion not, an aggressive doge. Attorney Cohen asked if she felt Mr. Pearson was honest with her. She said yes. Stated he is committed to Epic and his training. Epic is neutered. Cathy stated she has been part of dog dangerous hearings previously and she has recommended to put a dog down. Stated she feels dog, Epic, can be trained. Stated this was the first time she heard of three bites. Relayed occasions at the house were territorial. She felt Epic's actions were play in regards to the Mr. Pearson's brother's incident

Attorney Cohen feels dog should continue with short leash and muzzle

Mr. Pearson spoke to the Board. Stated he is committed to the dog. Does not feel he should be put down. Feels dog doing really well with training. Stated dog training has trained him too. He has learned to use vibrating

collar, which gives a correction. Stated works very well. Stated Epic no longer barks when someone comes to the door. Plans to keep attending training for the dog and himself

Stephanie, owner K9 Edge, akc evaluator and trainer. Informed the Board, she does not take all dog bite cases. Normally combo of handler and dog and the handler needs to be willing. Stephanie mentioned testing Epic and at the time he did not know Stephanie. Explained one should never walk into a dog's space. Provided a scenario in which Mr. Pearson was handling Epic, about their fourth lesson, walked into Epics space. Epic stayed no movement no growl no lip curl. Epic was looking at Mr. Pearson. Cathy went quickly towards dog, he did not move, dog looking at Mr. Pearson. Walked up to Mr. Pearson, bumped him, dog looking at Mr. Pearson. Does not believe dog is aggressive. Feels dog had no former training. Training Mr. Pearson how to handle the dog

Attorney Kennefick asked if Board has any questions

G. Heavey, K9 Edge stated dog not aggressive. How do you explain what happened to Ms. Benoit.

Cathy answered she was not aware of the incident. Stephanie, stated Epic was only at the house for two weeks at time of Benoit bite. Spoke to the Decompression period. Should have scheduled the dog more, had been more regiment. Mentioned maybe the cane could have caused the dog concern. Stated dog was in a new situation at the time

G. Heavey, do you have a background on the dog?

Mr. Pearson stated dog from Georgia. Tracked down original owners. Owners stated no problems, was a timid dog. Asked if they could come visit dog. Dog spent year and a half in a shelter

G. Heavey, asked Ms. Benoit about dog being a lunatic. Benoit stated chewed things, ran around living room. Barking and jumping(horrible) Jim could not get him to listen so dog spent a lot of time in his pen

Question was asked if there was any interaction with the dog at time of bite on couch. Ms. Benoit stated, No I was watching tv. Ms. Benoit is no longer in the same house as the dog.

Attorney Cohen, asked if Sara Pearson, daughter of both Mr. Pearson and Ms. Benoit could speak. Sara, stated her parents argue. And felt the dog is protecting himself from that behavior

G. Walker stated was confused regarding responsibility for dog inside the house. Attorney Kennefick addressed the question and gave various options

JR Colby asked Mr. Pearson, if he told Mona to get into the bathroom. Mr. Pearson replied, first he grabbed the dog by collar and now feels now that was improper, he should have grabbed back legs and stated has learned a lot

D. Packer, asked Mr. Pearson if he takes any responsibility of the event. Mr. Pearson replied Yes, he does. Mona does not want the dog, so he moved into the other house with dog

D.Packer stated Mr. Pearson set the dog up for failure. Needs to take ownership

D. Packer asked Mr. Pearson how he was going to work out his relationship with Mona? Mr. Pearson stated that has not been discussed yet

D. Packer asked, are you going to continue to co habitat? Mr. Pearson stated doubtful

A.Greco asked, you and Mona living in separate houses. What is the physical distance? Mr. Pearson responded 250 feet . A. Greco asked if the dog is currently leashed at all time? Mr. Pearson replied is on a heavy-duty zip line and he walks him several times a day and he goes to training. A. Greco asked if the dog is crated? Mr. Pearson answered Yes, at night, all night and if I have to leave the house I put him in crate not for more than an hour or two

Carol Hollis, neighbor, has met dog. Felt was a loving dog. She petted. Never seen aggression in the dog and is not afraid of dog

Leslie Mathews, stated it is hearsay. Does not understand why dog getting preference over a person who has been violated in such a way

Motion: G. Heavey moved to closed public hearing seconded G. Walker, and voted unanimously

Attorney Kennefick explained the process to determine dangerous, nuisance or neither.

Motion: JR Colby moved to determine to deem dog dangerous, second D. Packer and voted unanimously

Discussion: Alicia read the Statutory remedies for a Dangerous dog.

JR mentioned Dominance in relation to animals. Animals looking for the smallest in the group. Animals know who they can exert dominance on. Feels hard to change that behavior.

G. Heavey, feels dog may have been protecting Mr. Pearson but feels dog's reaction was grossly disproportionate. Maybe with training that will help

Attorney Kennefick explained board has 7 options in regards to Statutory Remedies for a Dangerous Dog. Number 7 or any combination of the first 6

- G. Heavey read the 7 remedies for a dangerous dog:
  - (i) that the dog be humanely restrained; provided, however, that no order shall provide that a dog deemed dangerous be chained, tethered or otherwise tied to an inanimate object including, but not limited to, a tree, post or building;
  - (ii) that the dog be confined to the premises of the keeper of the dog; provided, however, that "confined" shall mean securely confined indoors or confined outdoors in a securely enclosed and locked pen or dog run area upon the premises of the owner or keeper; provided further, that such pen or dog run shall have a secure roof and, if such enclosure has no floor secured to the sides thereof, the sides shall be embedded into the ground for not less than 2 feet; and provided further, that within the confines of such pen or dog run, a dog house or proper shelter from the elements shall be provided to protect the dog;
  - (iii) that when removed from the premises of the owner or the premises of the person keeping the dog, the dog shall be securely and humanely muzzled and restrained with a chain or other tethering device having a minimum tensile strength of 300 pounds and not exceeding 3 feet in length;
  - (iv) that the owner or keeper of the dog provide proof of insurance in an amount not less than \$100,000 insuring the owner or keeper against any claim, loss, damage or injury to persons, domestic animals or property resulting from the acts, whether intentional or unintentional,

of the dog or proof that reasonable efforts were made to obtain such insurance if a policy has not been issued; provided, however, that if a policy of insurance has been issued, the owner or keeper shall produce such policy upon request of the hearing authority or a justice of the district court; and provided further, that if a policy has not been issued the owner or keeper shall produce proof of efforts to obtain such insurance;

- (v) that the owner or keeper of the dog provide to the licensing authority or animal control officer or other entity identified in the order, information by which a dog may be identified, throughout its lifetime including, but not limited to, photographs, videos, veterinary examination, tattooing or microchip implantations or a combination of any such methods of identification;
- (vi) that unless an owner or keeper of the dog provides evidence that a veterinarian is of the opinion the dog is unfit for alterations because of a medical condition, the owner or keeper of the dog shall cause the dog to be altered so that the dog shall not be reproductively intact; or
- (vii) that the dog be humanely euthanized.

Motion: G. Heavey move to order the following remedies 1,2,3,4,5 and recommend dog and Mr. Pearson to continue with training, and be confined to 36 Cottage Road second, D. Packer and voted unanimously
