At 7:00 p.m. Chair Alicia Greco called the meeting to order with a salute to the flag

Public Comment

Jim Moran, 104 Elm Street, inquired about the cost for solar farm proposed on the landfill on Boston Avenue and status of drawings, information and cost for Town Hall

Justin Londergan, 38 Larkin Road, stated has heard a lot of developments. Reiterated the group takes issue with how and why the bridge repair on Larkin Road is transpiring. Stated agrees regarding public safety. Believes however the use should be for emergency access not through traffic. Reasons being road narrow, fresh pavement will cause speeding, and dangerous to children who live on the street. Stated he understands the MOU will be signed by the Newbury Select Board February 8th. Asked to consider and discuss at the February 8th meeting mitigation efforts including the breakaway gate. Believes can satisfy all parties involved and similar gates have been used. Asked for this to be on Agenda ASAP. Stated they are prepared to bring the gate proposal to Town Meeting in April.

A.Greco clarified February 8th is not a set date for this topic to be on agenda

Catherine Londergan, 38 Larkin Road, spoke regarding discussions she has had with other mothers on the street with small children and stated she does not support opening the road to through traffic. Mentioned road too narrow for two-way traffic, approximately 20 small children on the Newbury side, is a critical safety hazard. Asked to discuss mitigation efforts including a gate option. Ms. Londergan read a statement from another community member who was unable to attend the meeting

Bernadette Forti, 79 Larkin Road asked if the Army Corps of Engineers approved the same type of bridge that is there now

A.Greco reiterated this topic is not on the Agenda tonight therefore there cannot be a discussion

Ms. Forti went on to express she is concerned about safety. Mentioned mitigation and specifically a break away gate as an option. Stated she sensed resistance from the Board regarding the gate and asked if any of the Board members opposed the breakaway gate

A.Greco again stated there cannot be a conversation regarding this tonight

Ms. Forti asked when will be on the Agenda, who decides when will be on an Agenda and how does she get notified of that

A.Greco replied you can sign up on the Town of Newbury website and you will receive an email. Stated she sets the Agenda

Jack Rybicki, 37 Larkin Road, spoke regarding Georgetown Select Board and how they provided the Agreement that Newbury is currently reviewing, to residents. Asked for the Board to think about a couple provisions. 2.7, asked that there be communication to the neighborhood during construction. 2.8, stated need peer review control, spoke regarding paving why allowing Georgetown person to emergency open up our road and asked if this would be something you would also do in the future with Newbury developers and asked for these to be considered when on a future Agenda

Covid Remote meeting discussion and vote

Stated majority of communities meeting in person. Stated the Governor's allowance of virtual meetings only allowed until April 1st unless extended. A. Greco opened up to the Board for comments

G. Heavey asked if the other Town's had mask mandates and or vaccine mandates. Stated does not feel we should go by what other Town's are doing without having their full policy such as mask wearing requirements. Also commented as to why we are following a Policy from 2017 when the Governor allows to meet virtually until April 1st.

M. Doyle commented he will be attending a Veteran's meeting this week which is held virtually and also stated felt should have the option to hold the meeting virtually

A.Greco asked Chief Lucey to provide an update regarding COVID numbers

Chief Lucey reported the numbers were down 28% compared to the last report. Stated with home tests we may not be given all the data. But testing at home, not sick enough to go to hospitals and recovering at home, that is a good sign. Commented hospitalization, which he gets from the DCH website, were down. There were 88 cases about 10 days ago now down to 28. Stated the numbers are trending down but also mentioned it is a fluid situation

There was mention that the Town Hall does currently have a mask policy in place. Employees must wear a mask if interaction is indoors and within six feet of one another
