Community	Fiscal Year	Accomplishment
Solana Beach, CA	2006	Secured \$300,000 in Regional Sediment Management funds for the Corps to study the high-use and dynamic area of Fletcher Cove in Solana Beach and consider plans to place material there from regional sediment sources.
Bethany and South Bethany Beaches, DE	2006	\$3,000,000 to begin construction of the Bethany and South Bethany beaches.
Martin County, FL		\$1,500,000 in Construction General funds so the Corps can begin construction of the St. Lucie Inlet Improvement project, which will modify the jetties of the St. Lucie Inlet to provide safer navigation in the East Coast's most dangerous inlet.
City of Sarasota, FL	2006	\$325,000 in Operations and Maintenance funding for the Corps, the City, and the County to study regional sediment management opportunities in the region.

St. Lucie County, FL	2006	\$150,000 in Construction General funding to continue the Fort Pierce General Reevaluation Report.
Tybee Island, GA	2006	\$125,000 in General Investigations funding to continue work on Tybee Island's feasibility study.
Avalon, NJ	2006	\$11,600,000 in Construction General funding to continue construction of the Townsends Inlet to Cape May Inlet project.
Middle Township, NJ	2006	\$2,850,000 in Construction General funds to continue work on the Reed's Beach and Pierce's Point beach nourishment project.
Middle Township, NJ	2006	\$1,838,000 to continue construction of the Villas and Vicinity shore protection project.
Carolina Beach, NC	2006	\$3 million in additional funds to enable scheduled periodic renourishment of beach.
Carteret County, NC	2006	Secured \$3,000,000 for the Section 933 project that places sand dredged from Morehead City harbor on the beaches of Carteret County.
Fire Island, NY	2006	\$1,875,000 for the Corps to continue work on the Fire Island to Montauk Point feasibility study.
Pawley's Island, SC	2006	\$154,000 to finish the feasibility study of Pawley's Island and work to secure a Chief's Report before beginning preconstruction engineering and design.
Jefferson County Waterway and Navigation District, TX	2006	Secured \$12,130,000 in Operations & Maintenance funding for the Corps to dredge and maintain different sections of the roughly 40-mile Sabine-Neches Waterway.
Norfolk, VA	2006	Secured \$200,000 in General Investigations funding for the Corps to continue the Willoughby Spit General Reevaluation Report.
Brunswick County, NC	2005	Achieved \$200,000 in FY 2005 mid-year funds for the Brunswick County, NC General Reevaluation Report.
Mantoloking, NJ	2005	\$396,000 in FY 2005 additional funding for the Manasquan to Barnegat Inlet feasibility study.
Imperial Beach, CA	2005	\$750,000 for a Section 107 project that will place beach-quality material from the San Diego Harbor deepening project in the nearshore area of Imperial Beach.
San Clemente, CA	2005	\$178,000 to finish the City's feasibility study.
Lee County, FL	2005	\$750,000 to add to funds already appropriated by Congress to pay for the federal share of the Lee County beach construction project.

Community	Fiscal Year	Accomplishment
Martin County, FL	2005	\$1,250,000 to add to funds already allocated for construction of the Martin County project from the Hurricane Disaster Relief emergency supplemental appropriations bill.
St. Johns County, FL	2005	\$250,000 to pay for preconstruction engineering and design before the Corps renourishes the project after the hurricanes of 2004.
St. Lucie County, FL	2005	\$750,000 to add to funds already allocated for construction of Ft. Pierce Beach from the Hurricane Disaster Relief emergency supplemental appropriations bill.
Tybee Island, GA	2005	\$102,000 to initiate a Limited Reevaluation Report (LRR) of the existing shoreline protection project.
Avalon, NJ	2005	\$12,600,000 to complete the construction of a seawall along the Borough's shorefront.
Cape May Point, NJ	2005	\$5,164,000 to complete the beach fill component of the Borough's shoreline protection project.
Middle Township, NJ	2005	\$475,000 to complete a Limited Reevaluation Report (LRR) and initiate construction of the Reeds Beach to Pierces Point shoreline protection project.
Fire Island, NY	2005	\$1,400,000 to continue the Fire Island to Montauk Point Reformulation Study of the southern Long Island shoreline.
North Topsail and Surf City, NC	2005	\$214,000 to continue the feasibility study of the communities' shoreline protection project.
Galveston and Jefferson Counties, TX	2005	\$325,000 to continue the feasibility study of the counties shoreline.
Jefferson County Waterway and Navigation District, TX	2005	\$10,895,000 to make O&M repairs to the Sabine-Neches ship channel.
Norfolk, VA	2005	\$50,000 to continue a General Reevaluation Report (GRR) for the City's shoreline protection project.
Walton County, FL	2005	Secured \$400,000 in funding for the Walton County feasibility study to speed the study up. This was the only earmarked funding in the Hurricane Disaster Relief emergency supplemental appropriations bill passed after the hurricanes of 2004 in Florida.
