Call to Order: At 7:00 p.m. Chairwoman Alicia Greco called the meeting to order with a salute of the flag

Motion: JR Colby moved to open the meeting, seconded G. Walker

A.Greco introduced herself as chair and stated as chair she hoped to work towards a greater sense of community, to promote ethical conduct, to provide transparency in our local government and improve communication. She commented would like to dispel recent rumors including a false story regarding the BCAC closing its doors, confirmed this is not true and provided the website where a calendar of events may be found and also clarified a previous conversation regarding Xfinity not providing Newbury senior citizens a discount, read from a letter provided by Xfinity which confirmed a \$2.00 discount is offered if certain criteria is met.

G. Heavey commented did not feel this was a true senior discount for citizens 65 years of age and older

Public Comment:

Justin Londergan – 38 Larkin Road – stated he and his wife began a petition opposing the proposed culvert on Larkin Road, per Justin petition consisted of 255 citizens. Mentioned was told bridge needs to open due to safety concerns. His understanding is the Town of Georgetown has concerns regarding accessing the bridge. Stated he has learned the cost to repair culvert is \$250,000, why not repaired with tax dollars? Feels two reasons why town did not address; one did not address an urgent safety Issue or two.it is not emergency situation. Stated gave the Town the benefit of the doubt, the reason is number two. Feels it is a like to have not a must have. Does not understand why Newbury is getting on board with this project. Feels the bigger safety Issue is with pavement not safe, as only 16 foot wide. Again stated if the bridge opening was a safety hazard the Town would have addressed in the last decade and has not done so as it is not a safety issue. Opening bridge is the safety issue. Lastly, why is town of Newbury entertaining bridge? Stated he/neighborhood does not support the Georgetown Agenda and asked that the Board not support that agenda also. It has existed as is for 10 years and should stay the same.

Jim Moran, 104 Elm Street – discussed the proposed Town Hall complex at 25 High Road. Mr. Moran stated believes a bad plan, feels lot too small and cost too high. The project time line to complete, he understands, is three years. 2018 plan was voted down by 64% of voters. Also, stated COA better in separate building. The COA voted at yesterday's meeting to continue this conversation with a bigger group. Agenda that came out today states want a revote a week from now. Reiterated, believes complex not a good plan.

Leo Rybicki, 37 Larkin Road, stated he was the author of the post mentioned earlier. Asked is the Byfield COA going to have the same arrangement it has had for the previous 15 years or is there a coming change in the BCAC. Asked if there was any plan for the COA to take over hours at BCAC.

David Maida, 61 Larkin Road, spoke about the development regarding Larkin Road. Stated does not the legalities of the issues but feel is it a quality of life issue. 20 years at current address, in beginning bridge was open, and fast driving, worried for safety of kids. Street is still filled with families and kids and have only known as a dead end and a safe area for their kids. Bridge opening will change the quality of life for the people on the street. Stated the Elected Officials are elected to represent and protect the integrity of the town. Spoke about the neighbors caring about each other and have turned out tonight. Are there cost issues of wear and tear on the road? Does this affect my property value? Is my property worth more or less if dead end or thru way? Understands the rights of the Developer. Maybe a compromise, perhaps an emergency gate is a solution?

Megan Rogers, 75 Larkin Road, direct abutter of development, last house right before the bridge. Commented narrow road. Wonderful community, traffic is fairly fast now, as a dead end. Feels detrimental if road opens. Feels the emergency access does not make sense. Hoping board will hear their voices and not allow bridge to open.

Bernadette Forti, 79 Larkin Road, who is fixing the bridge? Answer provided the Developer. Who issues the permit for bridge construction? Was explained needs to go through process. If there is wetlands will need to go through Conservation. Where does the Army Corps of Engineers get involved? Answer provided did not know why the Army Corps of Engineers would get involved. Stated her concern is safety and her property getting flooded as not certain culvert can handle heavy rain. Answer provided that generally storm water calculations are handled by the Planning Board and Conservation. Board member stated not certain if Army Corps of Engineers gets involved with streams. Also mentioned Corps did not get involved with the Main Street Bridge. Ms. Forti asked if there is a construction mitigation plan. Board member explained these are questions that should probably be answered at the Planning Board level. Ms. Forti asked if the Planning Board and Select Board talk to each other. Board member explained, our authorities do not usually overlap. Select Board has limited role in this. Ms. Forti mentioned the abutters have concerns regarding the culvert and handling a lot of water. Asked for the difference between a culvert and a bridge. An explanation was offered. Board member assured her we are not taking this lightly and glad to hear from everyone. Board reassured the Developer has to meet a certain level of criteria. Board member explained when this project is actually ready to cut into the road it will come before the Select Board again. Is there any possibility abutters land would be taken by eminent domain? A request of the Board was made that she put all her questions in an email and send to Select Board.

Connor,65 Larkin Road, mentioned a big flood ditch which Army Corps of Engineers may need to get involved in. Was told no culvert could withstand the flood waters. Feels needs a full scale bridge. Asked board to exercise any and all rights, do everything they can to stop the bridge opening.

Catherine Londergan, 38 Larkin Road, width of road is 16 feet are there any requirements for road width to be a paved through way. What is the benefit to Newbury? A Board member provided a little history. Ms. Londergan stated no one knew the development was happening, that the culvert was happening. What can we do to influence things and what can you do to represent and address our safety concerns? Board member explained when this comes before the Select Board again feels have been informed of the neighborhoods concerns, and wanting road closed and Board will be prepared to speak to what that entails and if that is feasible/possible.

David Maida, 61 Larkin Road, if bridge is not repaired can the property still be developed? Board was not certain

Board reiterated to please send questions and concerns in writing to the Select Board

Board member asked what will be the responsibility of the Select Board when this comes before them

Answer given, the legal documentation to allow the work to be done on Town property

Nan McKenna, 16 Parish Road on the Georgetown side, wondering do they do have to widen the street to meet the Bylaws? To the best of the Boards knowledge would not be required to widen the street.
