Town Administrators Report

MVPC Traffic Analysis

- MVPC placed the counters on Larkin Road (near the Parker River Bridge and north of Millstone Lane) and on Central Street (one on each side of Larkin). They collected volume, speed, and vehicle classification information
- Data will be used in our Heavy Truck Exclusion Application

Grants

- Before he retired from the Board of Library Trustees, Dick Passeri had asked about electric charging stations at the Library
- Have preliminary approvals

Grants

- We have submitted an Eastern Federal Lands Access Program Project (FLAP) Grant application in conjunction with the City of Newburyport and the Parker River National Wildlife Refuge
 - The grant funds will be used for a Planning/Technical Study to determine the feasibility of raising the turnpike, including cost estimates, construction timelines, environmental impacts and mitigation requirements, cost/benefit analysis, and permitting requirements. Further, the conceptual plan for raising the turnpike did not include any pedestrian or cycling infrastructure; and this proposed Planning/Technical Study would include consideration for multimodal infrastructure, e.g. improved shoulder/edge conditions, lane widening, traffic calming, and emergent solutions for advancing shared streets principles.

Economic Bond Bill

- Senator Tarr notified us today that the Economic Bond Bill includes funding for two of Newbury's projects:
 - o \$50,000 for the Main Street Bridge Railing Project
 - o \$333,334 for the Larkin Dam Removal Project
 - o Grateful for Senator Tarr's efforts on Newbury's behalf

The Merrimack River Dredge

• Project contract was awarded by the USACE last night (7/28). With this, the anticipated start is for mid-September as planned, however, there are still a few boxes to check before shovels are in the ground.

Road Salt

 The Towns Road Salt bid also came in about \$18 more per ton (another \$30K based on last year's tonnage, 1,500)

Household Hazardous Waste Day

- The Board of Health is sponsoring a HHW day on Saturday, October 15th from 9am to 1pm at the Newbury Elementary School at 63 Hanover St.
- Accepting oil based paints (NO latex paints) varnishes, pesticides, pool chemicals, gasoline and other household hazardous chemicals
- Cost for Newbury residents are \$25 for up to 10 gallons/lbs or \$40 for up to 25 gallons/lbs
- Non-residents may attend from 12-1:00pm and will pay the full \$60 fee
- You may prepay/preregister at the Newbury Health Department Office located at 12 Kent Way, Mon, Wed & Thurs 12-4 and Tuesday from 12-7
