Public Hearings:

Town of Newbury (81 Central St, Manter Fields) – a Request for Determination of Applicability for work to remove the existing 5' x 10' steel plate used for brook crossing and replace it with an ADA compliant foot bridge in the same location.

Gerald Fandetti (7 Hutchins Way) DEP #050-1370– a Notice of Intent to replace an existing single-family home with a new home elevated on pilings. Continued from 11/16 meeting.

David Manty (0 Pine Island Rd/Lot 5) DEP #050-1330 – a Notice of Intent to construct a dock/pier, ramp, and floating dock within salt marsh resource area and ACEC. Continued from 11/16 meeting.

Commission Discussion:

Certificates of Compliance:

Michael Kirkpatrick (8 12th Street) DEP #050-1277 – a request for a complete Certificate of Compliance for an Order of Conditions issued 12/6/2018 to remove the existing structure and foundation, and construct a new single-family dwelling on piles with parking below and new utility connections.

Tim Sheehan (4 35th Street) DEP #050-1299 – a request for a complete Certificate of Compliance for an Order of Conditions issued 7/24/2019 to demolish the existing single-family structure and construct a new one on piles, included dune grass restoration.

Extension Permits:

Susannah Gordon (237 Middle Road) DEP #050-1195– a request to extend the Order of Conditions issued 3/24/2016 to construct a raised platform for temporary boat storage, a gangway, and a bottom-anchored seasonal float within coastal resource areas. This is the second extension permit request, and the current extension is due to expire 3/24/2022.
