

**Peter Phippen, MVPC (Newbury Salt Marsh, various locations) File #NCC-394** – a Request for Determination of Applicability for work to control Common Reed (Phragmites australis) throughout the salt marshes of Newbury, including the Plum Bush Creek area, the salt marshes to the south of the Plum Island Turnpike Bridge, and those located along the Parker and Mill Rivers.
