## **DOG LICENSING INFORMATION**

**DOG LICENSE FEES:** \$10.00 spayed/neutered, \$15.00 intact. Proof of Current Rabies Vaccination is required.

#### Information regarding fines/fees for unlicensed and/or unvaccinated dogs:

Unlicensed fines and fees are in addition to the license fee and are effective beginning FEBRUARY 1ST. State Fine for unlicensed dog(s): \$50.00 per dog - State Fine for unvaccinated dog(s): \$100.00 per dog Town of Newbury late fee: \$10.00 per dog

New residents and newly purchased or adopted dogs are not subject to fines or late fees if licensed within 30 days. Dogs <u>may</u> be licensed as soon as they receive a Rabies vaccine but <u>must</u> be licensed by 6 months of age.

If you no longer live in Newbury or if your pet is deceased or has been relocated, please notify the Town Clerk's office no later than Feb. 1<sup>st</sup> at 978-465-0862 ext. 315 or townclerk@townofnewbury.org.

Fees: Resident (17-64 years): \$25.00; Senior (65+ years) or Veteran: \$20.00; Replacement Stickers: \$5.00

Instructions:

The Town Census/Street Listing or a Real Estate Tax Bill will be used to verify residency; please ensure a copy of your R/E bill is included with this application to expedite the process. If you rent a residence, you must appear on the town's list of residents and you may be required to provide proof of lease or rental agreement. Please provide the following:

- 1. A copy of the R/E tax bill or current lease agreement.
- 2. Copy of all car registrations for which you are applying for stickers. Vehicle registration must match the property owner(s)/resident as listed on the list of residents and/or the R/E Property Tax bill.
- **3.** If vehicle(s) are owned by a business, please have the business owner provide a signed statement on company letterhead indicating that you are authorized to use the vehicle including the vehicle make/model and license plate number.
- 4. If you are applying for a senior (65+) sticker, please include a copy of your driver's license. Veteran status, if applicable, will be verified by the Town Clerks records or DD214.
- 5. Mail the application and required documents with a check payable to the "Town of Newbury" for the amount due in an envelope separate from other Town correspondence to:
